The management, Sree Siddaganga Education Society, Sree Siddaganga Math is pleased to extend the 7th revised scales of pay to the regular non- teaching staff of SIT with effect from 01.07.2024 and monetary benefit from 01.01.2025, as per above Govt. Order dated 23.08.2024 with modifications.

1. The fixation formula structured by the Government of Karnataka is adopted with certain modifications while revising the pay scales, reckoning with the financial resources of the institution, as hereunder.

Revised Basic Pay =Existing Basic Pay as on 01.01.2023 X multiplication factor. Where multiplication factor = 1 + (DA of SSES at 27.85% as on 01.01.2023 + Fitment benefit at <math>17.5% / 100 = factor of 1.453.

2. The Dearness allowance is sanctioned at 3% from 01.01.2025.

Future grant of Dearness allowance shall be at the rate of 65% of DA increase by the State Government from January to December of the preceding year and shall be payable w.e.f. 1st January of the succeeding year and so on.

3. The House Rent Allowance is 7.5% of the revised basic pay as per the conditions stipulated in the GO SRP 2024 dated 23.08.2024.

Subject: Sanction of Revised 7th state scale of pay to the Eligible Staff of

SSES, SIT, SPT, SSCP and SSINS & RC.

Reference: SSES No. 869-872 /2025-26 dated 30.06.2025

In continuation of this office order under reference above, the fixation of pay in the 7th revised state pay scale shall be read as mentioned below-

Fixation of Pay:

- 1. Basic pay as on 01.07.2024
 - 2. SSES rates of DA as on 01.01.2023 at 27.85%
 - 3. Fitment benefit of 17.50%

After computing the above 1+2+3 emoluments arrived shall be fixed at the next cell of the appropriate pay in the revised Pay scale as on 01.07.2024

OR

The basic pay as on 01.07.2024 shall be multiplied by a factor 1.453
